Care Rights UK is your care champion, the charity focused on defending the rights of people in care.

We want people to know their rights and how to use them. We offer information, advice and support to empower people using care services and the relatives and friends who help them.

As a community of families and experts, we have joined forces to fight for better lives for people in care. We identify poor care and highlight good practice, and demand a better care system.

Care Rights UK brings together the charity, the Relatives & Residents Association, and the Rights For Residents campaign group. In February 2023 we joined forces to create a powerful new voice for people needing care and their families.





Reflecting on 2022-23

The past year has been extremely tough for people needing care and their families. The pandemic and the response to it continued to have a devastating impact. The crisis engulfing social care left people without the support they needed to live safe, dignified, fulfilling lives.

We worked tirelessly to call this out. We were a lifeline of support for families. We fought for people's rights and we gave voice to the voiceless.

Empowering older people and their families and carers

We supported bereaved, distraught and anxious families who tell us they were left feeling bereft, frustrated and powerless by the system.

Our helpline was a lifeline for people needing care and their families, empowering them to challenge poor practice and bring about positive change in their lives.

With our support a stroke survivor used human rights law to secure access to a wheelchair in her care home, giving her mobility and a better quality of life

Empowering older people and their families and carers

The Rights For Residents Facebook group has been a beacon of light for families to support each other, creating a safe, friendly space and a community of voices empowering each other to speak out and achieve better care.

Our accessible resources and tools empowered people about their rights, including videos, template letters, guides and frequently asked questions (FAQs).





Raising awareness

Our campaigning shone a spotlight on the continued harm caused by the Government's mismanagement of the pandemic and called for people to be reunited with their family carers.

We marked the third anniversary of lockdown with a <u>video</u> featuring loved ones lost in care during the pandemic, alongside a <u>poem</u> read by Rights For Residents Ambassador, Ruthie Henshall.





Raising awareness

70+ national organisations joined our <u>call</u> (in collaboration with our friends at John's Campaign) for a new right to a Care Supporter, including large health and care providers.

We made hundreds of media appearances, including:

- TV interviews on ITV and BBC
- Six front page stories in national newspapers including the Times, Mirror and Guardian





Influencing practice

We wrote to the regulator, the Care Quality Commission (CQC), expressing continued disappointment with their role during the pandemic and concern about their guidance to care providers on infection control.

In addition, we raised concerns with the CQC about how they respond to people's poor experiences in care. Our evidence was quoted in CQC's report 'Listening, Learning, Responding to Concerns' where they accepted they needed to change, to better act on concerns.

CQC must urgently review its internal procedures, policies and training on how to respond when people share their experience of poor care.

Influencing practice

We supported a research project on the impact of evictions from care homes by King's College London. Our joint letter to the regulator requested urgent action to monitor and challenge inappropriate evictions. The <u>research</u> was covered by several media outlets, including a documentary on ITV's Tonight, on BBC Radio 4 You and Yours and on the front page of the Observer.

We worked with care providers to raise awareness of the rights of people needing care, speaking at conferences, workshops and private meetings.





Influencing practice

Our joint <u>letter</u> to local health leaders called for an end to isolation in care settings and for respect for legal rights.

We conducted a <u>survey</u> of visiting restrictions in care homes, which demonstrated the extent of additional restrictions in place in excess of Government guidance.

60% off respondents to our survey said that there were additional visiting restrictions in place in their care home, outside those which were stipulated in the Government guidance during an outbreak.

Influencing policy

Working in collaboration with John's Campaign:

- We convinced the Care Minister that change is needed over access to family carers; she is considering legal options
- A backbench business <u>debate</u> in Parliament secured further cross-party support for our call for a new legal right to a Care Supporter (Gloria's Law)
- Over 60 MPs <u>wrote</u> to the Secretary of State supporting our call for the new legal right

Influencing policy

We achieved significant improvements to the Government's guidance on visiting during the pandemic, to better protect the rights of people living in care.

We were awarded <u>core participant status</u> for the COVID public inquiry, submitting evidence to ensure lessons are learnt.

Our policy submissions were heavily quoted in several reports, including:

- Parliament's Joint Committee on Human Rights (JCHR) report on the Bill of Rights Bill, mirroring many of our <u>concerns</u> with this proposed new law
- An expert panel <u>report</u> on workforce, finding Government progress inadequate

The COVID guidance for social care has been updated today, which incorporates many of the changes called for back in April by the Relatives & Residents Association (R&RA) on visiting.
